

# ATHLETIC ACCESSORIES LIMITED WARRANTY

## LIMITED WARRANTY

This warranty is limited to materials for a specific time period.

## WARRANTY PERIOD

The warranty period is a period of seven (7) years from the date of original purchase. The SnapSports® *athletic accessories*, consisting of basketball systems, rebounders, light systems, and ball containment framing must be installed and operated according to their intended use. If any *athletic accessory* is defective in materials or workmanship, SnapSports, Inc. will replace the defective *athletic accessory* with like, or if unavailable similar, *athletic accessory* free of charge for the first four (4) years from date of original purchase and pro-rated as follows for the next three (3) years: Five (5) to six (6) years from date of original purchase: 45% of retail price at the time of claim. Seven (7) years from date of original purchase: 80% of retail price at the time of claim. Replacement cost will **not** include labor.

\*Light fixtures, basketball rims, backboard and pole pads, game nets and ball containment netting are covered for a period of three (3) years from the date of original purchase. There is no pro-rated warranty beyond the three (3) year warranty coverage period.

## WARRANTY RESTRICTIONS

This Limited Warranty covers normal consumer use. If the *athletic accessory* is used for any purpose other than its intended use, all warranty coverage is void. If *athletic accessory* parts are damaged by accident, alteration, unreasonable use, misuse, abuse, neglect, or other cause not arising out of defects in materials or workmanship, all warranty coverage shall be void. Appearance of replacement athletic accessory may differ slightly from original *athletic accessory*.

All SnapSports *athletic accessories* must be used within the parameters defined in each product's Specifications Guide.
