

# SURFACING LIMITED WARRANTY

## LIMITED WARRANTY

This warranty is limited to flooring materials for a specific time period. **Warranty does not apply to flooring in custom colors.**

## WARRANTY PERIOD

The warranty period is a period of sixteen (16) years from the date of original purchase. If any *flooring* is defective in materials or workmanship, SnapSports, Inc. will replace the defective *flooring* with like, or similar, *flooring* free of charge for the first five (5) years from date of original purchase. After the initial warranty period, defective *flooring* replacement will be pro-rated as follows: for the next three (3) years – six, seven and eight – customer is responsible for 50% of the current retail price; for the next four (4) years – nine, ten, eleven, twelve – customer is responsible for 65% of the current retail price; for the final four (4) years – thirteen, fourteen, fifteen and sixteen – customer is responsible for 80% of the current retail price.

Replacement cost will **not** include labor or actual freight charges.

## WARRANTY RESTRICTIONS

This Limited Warranty covers normal consumer use. If the *flooring* is used for any purpose other than its intended use, all warranty coverage is void. If *flooring* is damaged by accident, through improper maintenance or the use of unapproved chemicals or cleaning methods, alteration, unreasonable use, neglect, improper installation or other cause not arising out of defects in materials or workmanship, all warranty coverage shall be void. The interlocking system is included under the warranty unless the *flooring* is disassembled improperly (*based on installation instructions that provide proper disassembly procedure*). Appearance of replacement flooring may differ slightly from original *flooring*.

All SnapSports *flooring* must be used within the parameters defined in each product's Specifications Guide. Any installation or use outside of the intended specifications will void the warranty. ## WARRANTY SERVICE

Replaced *flooring* shall become the property of SnapLock Industries, Inc. This warranty gives you specific legal rights and you may also have other rights which vary from state to state. SnapSports, Inc. does not authorize any person to create for it any other obligation or liability in connection with this *flooring*. There are no warranties which extend beyond those provided for in this Limited Warranty. **THERE ARE NO IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. SUCH IMPLIED WARRANTIES ARE EXPRESSLY DISCLAIMED.** SnapSports, Inc. shall **not** be liable for loss of time, inconvenience, commercial loss, or consequential damages.
